The following States are Reciprocal and do not require sales tax: Alaska, Colorado, Iowa, Illinois, Missouri, Minnesota, New Mexico, Oregon, and Wisconsin. Florida requires proof of sales tax payment **ANY OTHER STATE MUST PAY CAL. SALES TAX**. The prices listed are for ground delivery (to a business address) and are an estimate only, your price may vary. You will be billed when the wine is shipped by the shippers. The wine is insured for \$100; additional insurance is \$1.00 per \$100. **Your wine will be insured for the full amount unless you specify otherwise.** If your State is not listed below you need to call Fitch Mtn. Pkg. (707-433-1247) and make arrangements to have your wine shipped to you.
